International Classification of Diseases

- A standard list of alphanumeric diagnostic codes developed by WHO for use worldwide
- Records patient symptoms/diagnoses
 - Claims reimbursement
 - Clinical research
- U.S. developed clinical modification (ICD-9-CM)
 - Expanded number of diagnosis codes
 - Developed procedure coding system

ICD-9 is Limited...

- 30+ years old
- Many categories full, difficult to incorporate emerging diagnoses/procedures/technology
- Imprecise for identifying diagnoses/procedures

The ICD 10 codes

- Greater specificity, more clinical information
 - Improved ability to measure health care services
- Increased sensitivity with grouping and reimbursement methodologies
 - Decreased need for claims documentation
- New codes enhance public health surveillance

ICD-10 Implementation

1990: Endorsed by World Health Assembly

2002: Published in 42 languages

• 138 countries for mortality

• 99 countries for morbidity

1999: U.S. implemented for mortality

· Death certificates

October 1, 2015...

- ICD-10 required for Medicare, Medicaid and everyone covered by Health Insurance Portability Accountability Act (HIPAA) claims
- Does not affect CPT coding for outpatient procedures

It's a **10**!

- Codes increasing from 13,000 to > 69,000!!!!
- · Focus on new codes relevant to your specialty
- For many PCPs, more like 20 50 codes
- · Code map your most frequently used codes
- · Avoid unspecified codes

3 main types of changes...

- 1. Definition Changes
- 2. Terminology Differences
- 3. Increased Specificity

But also ensure the information is captured in your documentation.....

1. Definition Changes....

Benign or malignant hypertension no longer exists

- Instead document the following...
 - Type: essential, secondary, etc.

Causal relationships: renal, pulmonary, etc

- Examples....
 - I10 Essential (primary) hypertension
 - I11.9 Hypertensive heart disease without heart failure
 - I15.0 Renovascular hypertension

2. Terminology Differences

Asthma codes updated for current classification

- Document severity:
 - J45.2 Mild intermittent asthma
 - J45.3 Mild persistent asthma
 - J45.4 Moderate persistent asthma
 - J45.5 Severe persistent asthma
- But also document...

Temporal Factors: Acute, chronic, intermittent, persistent, status asthmaticus

Cause: Exercise, cough variant, related to smoking, chemical or particulate cause, occupational

3. Increased Specificity

Abdominal pain documentation...

- Location: Generalized, RUQ, LLQ, periumbilical
- Quality of pain: Colicky, tenderness, rebound ICD-10 Examples...

R10.31 Right lower quadrant pain

R10.32 Left lower quadrant pain

R10.33 Periumbilical pain

3. Increased Specificity

Injury documentation

- Episode of Care: Initial, subsequent, sequelae
- Site: As specific as possible
- Etiology: How (e.g. sports, MVA, pedestrian)
- Place: School, work, other

 $\textbf{S42.001A:} \ \textit{Closed fracture, unspecified part of R clavicle, initial encounter}$

3. Increased Specificity


Laterality – Left Versus Right

C50.1 Malignant neoplasm, central portion of breast

C50.111 Malignant neoplasm, central portion of right female breast

C50.112 Malignant neoplasm, central portion of left female breast

ICD-10 diagnosis codes have between 3 and 7 characters



Not all ICD-10 codes must have 7 digits

- A code is invalid if it has not been coded to the full number <u>required</u>
- 7th digit only used in situations to provide data about the characteristic of the encounter

S42.001A: Closed fracture, unspecified part of R clavicle, initial encounter

Injuries and External Causes 7th Digit......

Value	Descriptor
А	Initial encounter
D	Subsequent encounter
S	Sequela

The 'Dummy' placeholder "X"

X is used with certain codes

- Allow for future changes
- To fill out empty characters when a code contains fewer than 6 characters and a 7th character applies

CMS ICD-10 Grace Period...

For the first year Medicare claims will not be denied solely based on the specificity of the diagnosis codes as long as they are from the appropriate family of ICD-10 codes.....

Family of Codes...

- CMS has defined the 'family' as the three character category, such as J45 (asthma)
- However, most categories include additional characters that provide more information, such as the type of condition. (for example, J45.21 for Asthma, mild intermittent, acute exacerbation)
- You still must provide a "valid" code, which means will likely have to report more than just the initial 3 category characters...

Only Medicare.....

- The loosening of the specificity requirement does not extend to Medicaid claims, only to those billed under the Medicare fee-forservice Part B physician fee schedule.
- It also doesn't extend to private payers unless those payers determine to offer similar flexibility

A word about HCC codes...

Hierarchical Condition Category Model

- Category of medical conditions that map to a corresponding group of ICD-9 codes
 - 3,000 ICD-9 codes map to 87 different HCCs
- ICD-10 will impact the number of HCCs
- HCC risk-adjustment codes are determined from claims data

HCC is for risk adjustment...

- Many payers moving to value based payments
- Higher rates of reimbursement to care for 'higher risk' patients
- A complete medical diagnosis builds an accurate health risk profile for each patient
- Report each patient's current & active diagnoses on an annual basis

External Cause Code Reporting

 If you have not been reporting ICD-9-CM external cause codes, you will not be required to report ICD-10-CM codes found in Chapter 20 (External causes of morbidity: V00-Y99) unless a new State or payer-based requirement about the reporting of these codes is instituted.

Routine exam, with HTN and not taking prescribed meds daily...

ICD-9-CM Diagnosis Codes

V70.0 Routine medical exam 401.9 Unspecified essential hypertension

ICD-10-CM Diagnosis Codes

Z00.01 Encounter for general adult medical exam w/ abnormal findings I10 Essential (primary) hypertension

T46.5X6A Underdosing of other antihypertensive drugs, initial encounter
